## Biography

Dan Kildee was born and raised in a working-class Flint family. After graduating from Flint Northern High School, Dan began his studies at the University of Michigan—Flint and Mott Community College. But for financial reasons, Dan dropped out of college to work and help support his family. Later, he would go on to graduate from Central Michigan University. He later accepted a Fannie Mae Foundation Fellowship at the Kennedy School of Government at Harvard University.

Dan's first job was as a social worker at Whaley Children's Center, where he helped children who had experienced trauma and abuse. In 1977, when he was just 18 years old, he was elected to the Flint Board of Education, becoming one of the youngest elected officials in the country. In 1984, he was elected to the Genesee County Board of Commissioners. In 1996, he was elected as Genesee County Treasurer. Dan established and served as the first President/CEO of the Genesee County Land Bank—Michigan's first land bank—to help strengthen neighborhoods, remove blight and redevelop land for productive use. The Genesee County Lank Bank served as a model for hundreds of other land banks across the country.

After nearly three decades serving in local government, Dan co-founded and served as the president and CEO of the Center for Community Progress, a national non-profit organization focused on urban land reform and revitalization.

In 2012, Dan was elected to the United States Congress. He first served the Fifth District, which included Genesee, Saginaw, Bay, Arenac, Iosco and Tuscola Counties. Later, he would be elected to serve the Eighth District, which included Genesee, Saginaw, Bay and most of Midland County.







## House Democratic Leadership

## CO-CHAIR OF THE DEMOCRATIC STEERING AND POLICY COMMITTEE

In the 118th Congress, Democratic Leader Hakeem Jeffries appointed Dan to serve as co-chair of the Steering and Policy Committee, where he was responsible for appointing members of the Democratic Caucus to their committee assignments and helped set the policy agenda for the Democratic Party.

## CHIEF DEPUTY WHIP OF THE HOUSE DEMOCRATIC CAUCUS

Dan was appointed by Majority Whip Jim Clyburn (D-SC) to serve as Chief Deputy Whip during the 116th and 117th Congress. In this leadership role, he was responsible for building support for key Democratic laws, including the *American Rescue Plan Act*, the *CHIPS and Science Act*, and the *Inflation Reduction Act*.

## CONGRESSMAN AND CIVIL RIGHTS LEADER JOHN LEWIS

One of Dan's friends and mentors throughout his time in Congress was the late Congressman John Lewis (D-GA), a civil rights leader who always encouraged "good trouble" to create a more just world. Dan and Congressman Lewis developed a friendship through their work together on the Ways and Means Committee.

In the final months of Congressman Lewis' life, as he was battling cancer and unable to cast his vote in person in the U.S. House of Representatives, he asked Dan to cast his votes by proxy.

"I spoke with him before each vote series. He was always so grateful. I thought to myself, 'John, I'm grateful to you, that you have given me this great honor, to cast a vote for the person who is most known for the sacred right to vote of any American in our nation's history."







## Delivering Aid During Flint's Water Crisis

In 2014, the State of Michigan—including the then-Republican governor and state-appointed emergency financial manager—switched Flint's water supply from the Detroit municipal water system to the Flint River, to try and save costs. A failure to properly treat the water resulted in high levels of lead leeching into the water supply—a major health crisis for 100,000 residents. Flint Families' concerns about the quality, smell and color of their water were dismissed by state officials for months. Years later, dozens of state officials, including Michigan's former Republican governor and state director of health and human services would be criminally charged for their neglect.

After hearing concerns from constituents, Dan organized four bipartisan congressional delegations to Flint, bringing dozens of Members of Congress to his hometown to draw attention to the crisis and urge federal action in response. He invited and brought President Barack Obama to Flint to hold a town hall with Flint families. Over two years, Dan would work with the Obama administration to deliver millions of dollars in aid, helping to expand Medicaid, Head Start and healthy nutrition programs for affected families.

In 2016, even while serving in the minority, Dan passed a \$170 million federal aid package through Congress that would help replace Flint's lead pipes, expand health care services and establish the Flint Registry.

When Republicans needed Democratic votes to pass a year-end budget bill, then-House Democratic Leader Nancy Pelosi (D-CA) deputized Dan to negotiate directly with then-Speaker of the House Paul Ryan (R-WI) to include a Flint aid package in the must-pass bill.

Pelosi said of Dan, "He went to the Speaker and said, 'I must have some remedy in our legislation.' They were never inclined to give us what we wanted on our side of the aisle. But the moral case that Dan Kildee made, the vision of something better for the people of Flint, the knowledge of the impact it was having on people, the personal stories he could tell, the hearings that he had, proved irresistible to the then-Republican Speaker of the House...this was quite remarkable."

In the years after the crisis, Dan continued to work in a bipartisan fashion with the Michigan congressional delegation to secure funding for the Flint Registry, having secured nearly \$40 million to continue its operations.

On the 10th anniversary of the Flint water crisis, Dan remarked, "America cannot forget what happened in Flint. The water crisis in my hometown is not an anomaly. Instead, it is a warning to the rest of the country that we must get serious about protecting public health and addressing the injustices we see in society."









## Securing the Release of Americans Abroad

Throughout his time in Congress, Dan worked to secure the release of American citizens unjustly detained abroad.

After learning of his constituent and other Americans being imprisoned as political prisoners, Dan immediately got to work. Beginning in 2013, alongside their families, Dan worked tirelessly to bring Americans detained in Iran home, including a former U.S. Marine and *Washington Post* journalist. He made frequent appearances on *Fox News* and other national cable networks to bring attention to their imprisonment.

In 2015, the U.S. House of Representatives unanimously passed Dan's resolution calling for Iran to release the American citizens it held as political prisoners. Speaking on the House floor, Dan said: "The world is watching Iran. Today, Congress will speak with one voice. This resolution states and this Congress will say with one voice that Iran cannot hold Americans as political prisoners if it wants to be taken seriously in the global community."

Over the course of several years, Dan worked with President Obama, Secretary of State John Kerry, and others around the world to advocate for their release. On one occasion, in 2015, U.S. Ambassador to the United Nations Samantha Power invited Dan to the United Nations General Assembly in New York as her guest. The assembly proceedings allowed Dan to meet directly with Iranian Foreign Minister Javad Zarif to advocate for the release of the American political prisoners.

On January 16, 2016, after years of advocacy, Iran released four political prisoners. Dan flew to Landstuhl Medical Base in Germany to meet the freed Americans and bring them home.









## Protecting Workers and Ensuring Fair Trade

#### REPLACING NAFTA

As a member of the Ways and Means Committee and senior Democrat on the Trade Subcommittee, Dan worked with President Trump to replace the North American Free Trade Agreement (NAFTA) with a more fair trade agreement, the U.S. Mexico Canada Agreement. Through his work on the Committee, Dan played a key role in finalizing aspects of the deal, including traveling to Mexico to negotiate with Mexico's President Andrés Manuel López Obrador regarding key elements of the agreement surrounding workers' rights, union representation and enforcement mechanisms. While the initial agreement proposed by President Trump failed to prioritize American workers, Dan and House Democrats made the deal better and stronger, culminating in a 385-41 bipartisan vote in the U.S. House and 89-10 vote in the U.S. Senate.

Since the USMCA went into effect, Dan has fought to make sure Mexico and Canada lived up to its commitments. He has fought for Michigan farmers to have access to sell their products in foreign markets, including Michigan corn growers being able to sell in Mexico. After reports of serious labor violations at an automotive plant in Mexico, Dan led efforts to protect the rights of workers.

## OTHER EFFORTS TO PROTECT WORKERS AND ENSURE FAIR TRADE

On the Ways and Means Trade Subcommittee, Dan also focused on combatting forced labor in the Dominican Republic's sugar industry. Traveling to the Dominican Republic in 2022, Dan met with workers in the sugar industry, Dominican officials, and then-President Luis Abinader, to push for basic rights and protections for all Dominican workers. After Dan's trip, U.S. Custom's and Border Protection took new action to prevent sugar produced by Central Romana in the Dominican Republic from entering the American market.

Upon reports that the Chinese government was using the Uyghur people as slave labor, Dan helped craft the *Uyghur Forced Labor Prevention Act* to ensure products made in China with forced labor don't enter U.S. markets and undermine American workers. The legislation passed the House with overwhelming bipartisan support and was signed into law by President Biden in 2021. Speaking on the law, Dan said, "When it comes to trade, we cannot allow nations with gross human rights violations like China to profit from forced labor at the expense of the American worker."

As China continues to rely on unfair trade practices and flood the U.S. and global markets with goods, Dan has fought to boost American manufacturing and ensure American workers are given a fair shot. The *Inflation Reduction Act* included Dan's *Solar Energy Manufacturing for America Act* to provide new tax credits to boost American solar manufacturing and protect American jobs. Dan's resolution to hold Chinese solar panel manufacturers accountable for violating U.S. trade laws and undercutting American workers passed both the House and Senate.







## Promoting Democracy Abroad

Throughout his time in Congress, Dan traveled the world on bipartisan congressional delegations, with Republicans and Democrats, to represent the United States Congress, strengthen alliances and advance American interests. Dan has been a leading voice in Congress on foreign affairs issues, particularly related to fair international trade, supporting human rights, expanding workers' rights, and promoting democracy in other countries.

Working with local Sudanese American constituents, Dan authored and passed a congressional resolution calling for the military to transfer power to a civilian-led government. When civil war broke out in April 2023, Dan led efforts by the American government to respond, working to surge humanitarian assistance and end the violence.

Working with local Pakistani American constituents, Dan passed a congressional resolution to promote democracy, support human rights and the rule of law in Pakistan. Dan said, "The people of Pakistan deserve free and fair elections and their human rights and fundamental freedoms must be respected."

## Cleaning Up PFAS Chemical Contamination

Because of what happened to his hometown of Flint, Dan knows that clean water is still a privilege, not a right, for many Americans. That is why he worked to remove lead in drinking water, and why he also led efforts to more urgently address PFAS chemical contamination.

Oscoda, home to former Wurtsmith Air Force Base, is one of hundreds of military sites that has PFAS contamination. Over decades, PFAS chemicals leaked into the groundwater around Wurtsmith, contaminating the drinking water of surrounding residents. Despite the Defense Department being aware of the contamination for years, they refused to act.

Dan got to work, calling attention to the issue. His advocacy piqued the interest of other Members of Congress, many of whom had never heard of PFAS chemicals. In 2019, he created the bipartisan Congressional PFAS Task Force to educate others on the threat PFAS chemicals posed to communities. Through his work, Dan brought together Republicans and Democrats to secure federal funding to clean up forever chemicals quicker and ensure that American service members exposed had access to the health care they need.

He introduced dozens of pieces of legislation related to PFAS, including the *VET PFAS Act* to require the Veterans' Administration to cover and treat PFAS-related health issues. Dan also introduced legislation, the *Expanding Seniors' Access to PFAS Testing Act*, to require Medicare to cover PFAS blood testing at no charge to seniors. After years of Dan's advocacy, in 2024 the Biden administration established the first-ever drinking water standard for PFAS.







## Lowering Health Care and Prescription Drug Costs

As a senior member of the Ways and Means Committee, Dan worked tirelessly to lower the cost of health care and prescription drugs. As the father of a Type-1 diabetic, he passed a new law signed by President Biden to cap the out-of-pocket cost of insulin for seniors at \$35 a month. He also introduced legislation, the *Affordable Insulin Now Act*, to cap the cost of insulin for all Americans, regardless of their insurance. Additionally, Dan wrote key pieces of the *Inflation Reduction Act*, including provisions allowing Medicare, for the first time

ever, to negotiate lower drug prices with pharmaceutical companies. He also championed a \$2,000 out-of-pocket cap on the cost of drugs for seniors, savings seniors thousands of dollars each year.

Dan fought dozens of attempts by Republicans to repeal the *Affordable Care Act* and take away coverage for millions of Americans, including those with pre-existing conditions.











## Protecting Social Security and Pensions

#### **DEFENDING SOCIAL SECURITY**

As a member of the Social Security Subcommittee, Dan worked to protect and strengthen Social Security. Nearly 68 million Americans—including retirees, individuals with disabilities and children who have lost a parent—rely on this vital insurance program.

Dan has fought to defend Social Security for over two million Michiganders. He introduced H. Res. 178, a resolution to reject any cuts to Social Security or privatize the program. He also introduced Social Security 2100, legislation to increase Social Security benefits for Michigan seniors by ensuring the wealthiest Americans—those making over \$400,000 a year—pay into Social Security at the same rate as teachers, firefighters and factory workers.

#### PROTECTING PENSIONS

Dan fought to protect the pensions of hardworking retirees so that people can retire with dignity. Dan authored the *Butch Lewis Act* to protect the pensions of over one million Americans, which became law in 2021.

For years, Dan led efforts to restore the pensions of Delphi salaried retirees. When General Motors filed for bankruptcy during the Great Recession, over 20,000 people had their pensions unfairly cut, including over 5,000 Michiganders. To fix this injustice, Dan introduced the *Susan Muffley Act* to restore the pensions of these retirees. In 2022, Dan passed this legislation out of the U.S. House of Representatives on a strong bipartisan vote, but the U.S. Senate failed to act.









## A Tax Code for Working Families

Dan served on the Ways and Means Committee, the tax-writing committee in Congress. After being appointed in 2019, Dan helped create a better tax system that benefits working families instead of the wealthiest Americans and biggest corporations.

Dan helped pass landmark legislation like the *Inflation Reduction Act* and the *American Rescue Plan* to help lower costs for Michigan families, put more money in workers' pockets, combat child poverty, and support small businesses. The *Inflation Reduction Act* also helped ensure the wealthiest individuals and biggest

corporations could no longer avoid paying their fair share in taxes and created a new tax on corporate stock buybacks. Dan expanded the Child Tax Credit, cutting child poverty in half, and tripled the Earned Income Tax Credit for low-income workers.

During the pandemic, Dan helped pass four relief packages to support Michigan workers, families and small businesses. These bills during COVID provided stimulus checks, provided sick leave, expanded unemployment insurance benefits, and accelerated vaccine distribution to millions of Americans.







## Bringing Manufacturing Jobs Back to Mid-Michigan

Flint—the Vehicle City—was the birthplace of General Motors and the United Auto Workers. For many decades, Buick and GM hired tens of thousands of automotive workers in Flint. But over many decades, in part due to unfair trade deals, Flint lost many manufacturing jobs.

Throughout his time in Congress, Dan fought to bring good-paying union jobs back to Michigan. He passed new laws to incentivize "Made in America" manufacturing policies and strengthen U.S supply chains to bring jobs back from overseas.

He was a key author of the *CHIPS and Science Act* to accelerate the production of American-made semiconductors. This law led public and private economic investments in mid-Michigan, including SK

Siltron in Bay County and Hemlock Semiconductor in Saginaw County. He also helped pass laws like the *Bipartisan Infrastructure Law* that helped attract new manufacturing facilities to the U.S. As a result, NanoGraf, which helps to build battery materials for electric vehicles, is constructing a new facility at Buick City in Flint that will bring 200 new construction jobs and 150 permanent jobs.

Dan also helped author key parts of the *Inflation Reduction Act*—including writing the Electric Vehicle Tax Credit to lower costs for consumers and create good-paying advanced manufacturing jobs. Together, these pieces of legislation led to over \$2.5 billion of investments, creating over 3,000 good-paying jobs in mid-Michigan.











## Improving Infrastructure, Eliminating Blight, and Promoting Affordable Housing

Dan always believed that every Michigander deserves to live in a safe and strong community. As Genesee County Treasurer, he founded the Genesee County Land Bank—the nation's first-ever land bank—to address abandoned properties that were destabilizing neighborhoods and driving down property values. And as a Member of Congress, he wrote legislation to expand resources for land banks in communities across America.

Dan worked hard to lower housing costs and make sure every Michigander has an affordable home. His bill, the Revitalizing Downtowns and Main Streets Act, would convert vacant commercial buildings to affordable housing units, while his Preserving Rural Affordable Housing Act would protect investments in rural affordable housing by lenders like Fannie Mae and Freddie Mac.

Beyond blight removal and increasing access to housing, Dan has driven major new investments to improve Michigan's infrastructure. He helped pass the *Bipartisan Infrastructure Law*—the largest investment in nearly a century—which has provided over \$5 billion to rebuild roads and bridges, over \$200 million to replace lead pipes and more than \$2 million to expand broadband to nearly one million homes in Michigan. This new law also fully funded the Great Lakes Restoration Initiative to protect the Great Lakes from pollution and invasive species like Asian carp.













## Honoring Our Veterans

#### **HONORING OUR PACT ACT**

As the son of a US Navy veteran, Dan wrote and passed the *PACT Act* to expand health care and benefits for veterans and their families exposed to toxic chemicals. Since becoming law, the *PACT Act* has helped tens of thousands of Michigan veterans.

Dan said, "Our servicemembers and military families sacrifice so much to defend our freedoms and keep our country safe. They should not have to fight to get the care they need for illnesses caused by exposure to toxins in the line of duty. This bipartisan legislation, supported by Republicans and Democrats, creates new benefits for veterans and their families and streamlines the claims process to make accessing health care and survivor benefits easier."

#### **VALENTINES FOR VETS**

Each year he served as a Member of Congress, Dan hosted a "Valentines for Veterans" card drive, partnering with local elementary schools to make and deliver handmade cards to local veterans, as a way to honor their service to our country.

#### VETERANS AND FIRST RESPONDERS RECREATION DAY

Dan hosted a Veterans and First Responders Recreation Day each year in the district as a way to honor veterans, first responders and their families. The free event, with kayaking, fly fishing, spin casting and biking, aimed to help veterans and first responders reduce stress and alleviate symptoms of PTSD. Caseworkers and VA officials were also present to help constituents deal with federal agencies.











Members of Congress annually could direct federal investments to community projects with demonstrated local support, commonly referred to as Community Project Funding. Through this initiative, Congressman Kildee was able to bring tens of millions of dollars back to mid-Michigan to grow our economy, create good-paying jobs and provide greater opportunity for working families.

CRITICAL HOME REPAIRS IN SAGINAW AND BAY COUNTY: Saginaw-Shiawassee and Bay County Habitat for Humanities are providing home repairs to improve the quality of housing for veterans and low-income households and lower their energy bills.

INCREASING ACCESS TO QUALITY, FRESH FOODS: North Flint Reinvestment Corporation is building a consumer-owned grocery store to improve access to quality, fresh food options.

HELPING FLINT RESIDENTS STAY SAFE IN THEIR HOMES: Genesee County Habitat for Humanity is helping Flint residents make home upgrades to address health and safety issues.

ENSURING STUDENTS GET THE CARE THEY NEED: The Genesee Intermediate School District is creating a nurse training pilot program in schools to improve health care for children.

IMPROVING CARE FOR
MID-MICHIGANDERS: Hurley Medical
Center is purchasing new critical care bed

Center is purchasing new critical care beds for their critical care units to improve care for patients.


STRENGTHENING HEALTH CARE SERVICES FOR SENIORS: Presbyterian Villages of Michigan is building a workforce development program for workers at senior living homes to provide better quality of care for seniors.

**INVESTING IN STUDENTS:** The Sylvester Broome Empowerment Village and Berston Field House are creating a program to provide educational and mentorship opportunities to students interested in STEM careers

INCREASING ACCESS TO MENTAL HEALTH SERVICES: The Greater Flint Health Coalition is establishing a Community Information Exchange to increase access to mental health services for patients who have unmet behavioral health and social needs.

ELIMINATING BLIGHT IN GENESEE
AND BAY COUNTY: The Genesee County
and Bay County Land Banks are eliminating
key public health threats and blight within
Flint and Bay City by demolishing the most
hazardous vacant properties.

REDUCING CRIME AND MAKING OUR COMMUNITIES SAFER: The Genesee County Sheriff's Office and Prosecuting Attorney's Office are creating Genesee County Justice Partnership for Reform to provide alternatives to incarceration that bring victims, offenders and members of the community together in a mediation process.



## ESTABLISHING A COMMUNITY HEALTH COMPLEX IN BAY COUNTY: Bay County

Health Department is building a health facility for public health, primary care, substance abuse treatment in a single-building complex to improve access to high-quality health care and social support services for residents.

#### SUPPORTING LAW ENFORCEMENT:

Eight mid-Michigan law enforcement agencies, as well as the Michigan State Police, are making critical upgrades to their local police departments based on the public safety needs of each community.

## ECONOMIC DEVELOPMENT FOR DOWNTOWN SAGINAW: The city

of Saginaw is making infrastructure investments to prepare downtown Saginaw for large-scale economic development, create jobs and attract investment.

### HOME IMPROVEMENT AND REPAIRS FOR MID-MICHIGAN HOUSEHOLDS:

Bay, Genesee and Saginaw Habitats for Humanities is making critical home repairs for veterans and low-income households, including for Flint residents to address health and safety issues.

#### **SUPPORTING COMMUNITY CENTERS:**

The YMCA of Flint, Dow Bay Area Family YMCA and the YMCA of Saginaw is upgrading and improve community centers across mid-Michigan.

#### **REMOVING BLIGHT ACROSS MID-**

MICHIGAN: The Saginaw County Land Bank Authority, in partnership with Buena Vista Charter Township and the Saginaw Basin Land Conservancy, is working to demolish dangerous, vacant properties, to eliminate health risks that can lead to diseases, asthma, and lead poisoning, and increase home values.

#### **IMPROVING TRANSPORTATION**

**RELIABILITY:** The Saginaw Transit Authority Regional Services (STARS) is increasing reliable bus service to Saginaw County residents and improving air quality through the purchase of large transit buses.

#### **DELIVERING FOOD FOR FAMILIES IN**

**NEED:** The Food Bank of Eastern Michigan, in partnership with a Saginaw-based organization, is helping distribute food to families, seniors and children struggling with hunger.

#### SUPPORTING SMALL BUSINESSES

AND ENTREPRENEURS: Central Michigan University Research Corporation and the Michigan Small Business Development Center are expanding resources for small businesses to improve innovation, inclusion and economic resiliency in mid-Michigan.

### EXPANDING AFTER SCHOOL PROGRAMS IN GENESEE COUNTY:

The Flint Institute of Science and History, in coordination with the Sloan Museum of Discovery, Flint Institute of Arts, Flint Soap Box Derby, Crim Fitness Foundation, and the Flint Institute of Music is expanding and improving after school Science, Technology, Engineering, Arts and Math education services to students across Genesee County.

### EXPANDING GENESEE COUNTY CHILDREN'S LITERACY PROGRAM:

Latinx and the Flint Genesee Literacy Network, through Mott Community College, are expanding language and literacy service programs to provide access to high-quality language education services for families and young children.

#### **GENESEE COUNTY BLIGHT REMOVAL:**

The Genesee County Land Bank Authority is demolishing dangerous and vacant residential and commercial structures to create new opportunities for homeowners.

## ESTABLISHING A COMMUNITY HEALTH CENTER ON EAST SIDE OF FLINT:


The Hamilton Community Health Network, Inc., is creating a medical facility on the east side of the city of Flint to improve access to affordable health care services for medically underserved communities.

## UPGRADING SUBSTANCE USE DISORDER TREATMENT FACILITIES:

The New Paths, Inc. is upgrading its substance abuse disorder treatment and recovery housing facilities to help increase public safety and promote public health.

#### **UPDATING ROAD INFRASTRUCTURE**

**AND SAFETY:** The Genesee County Road Commission, along with the city of Fenton and city of Grand Blanc, is working to improve the quality, durability, and safety of key roads in the community.



## PREVENTING FLOODS AND PROTECTING WATERSHEDS: Midland County is removing snag and debris from local waterways to prevent flooding.

## IMPROVING ROAD SAFETY AND INFRASTRUCTURE IN FRANKENMUTH:

The Frankenmuth Downtown Development Authority is constructing a roundabout and reconverting a roadway to improve safety and traffic flow.

#### **EXPANDING TRANSPORTATION**

**OPPORTUNITIES:** Saginaw Valley State University (SVSU) is connecting two transit authorities in Bay County and the City of Saginaw to offer reliable transportation to and from campus for students, faculty and staff, and community members.

COMMUNITY DEVELOPMENT AND ECONOMIC EXPANSION: Bay County is completing renovations on the Bay County Community Center and improving public safety by removing blighted vacant buildings in the community that contribute to crime.

The Michigan State Police and local mid Michigan law enforcement are making critical upgrades to their equipment, technology, patrol vehicles and vessels to improve public safey.

**CHARLES:** The Village of St. Charles is replacing lead and copper water service lines to ensure the safety of residents:-. drinking water.

#### **IMPROVING CLEAN WATER IN**

**FLUSHING:** The City of Flushing is making improvements to the Flushing Wastewater Treatment Plant to ensure proper treatment of wastewater flowing into the Flint River.

#### **DELIVERING CLEAN DRINKING WATER**

IN GENESEE COUNTY: The Genesee County Drain Commissioner is expanding drinking water infrastructure in Genesee County, reducing potential exposure to harmful toxins.

#### **SUPPORTING LOCAL STUDENTS:**

Central Michigan University is exposing secondary school students to health care careers, focusing on rural communities in Bay, Isabella, Midland and Saginaw counties.

#### PROVIDING AFFORDABE HOUSING

**IN FLINT:** Communities First, Inc. is transforming the Marian Hall building into affordable housing and converting the Masonic Temple building into a mixed use space for the Flint community.

#### **EXPANDING ACCESS TO**

**RECREATIONAL SPACES:** The Genesse County Parks and Recreation Commission is making updates to local parks, focusing on improving access for people with disabilities.

### COMBATTING DRUG AND HUMAN TRAFFICKING IN GENESSE COUNTY:


The Genesse County Sheriff's Office is expanding services for children who have been victims of crime and abuse, protecting them from trafficking and improving public safety.


